**Disciplinary Actions** 

The Commission is now publishing disciplinary actions at the end of the Commission Newsletter. On page two of this edition are disciplinary actions with effective dates of January 1, 2018 or later with respect to revocations, suspensions, and aggregate fines of greater than \$500. A licensee is listed twice if they received more than one action (i.e. Suspension and Fine).

The Commission often receives questions about the Code of Ethics requirement. While this course is necessary to maintain membership with your local REALTOR association, it is not required by the Commission.

The Code of Ethics may be used as part of your continuing education credit to maintain your real estate license, if it is at least 3 hours and is on the list of approved courses.
